FUTURITY / DERBY RULES AND REGULATIONS

1. 2D FUTURITY is open to horses foaled in 2017 and 2016 (4 and 5 years of age). Horses must never have competed in any barrel race including, but not limited to, registered shows, open shows, play days, rodeos or other futurities prior to November 15, 2020.

2. 1D DERBY is open to horses foaled from 2016 to 2014 (5 to 7 years of age).

3. AGE OF HORSE is determined as of January 1 of calendar year foaled. Photocopy of registration (FRONT & BACK) or veterinarian's affidavit of year of birth and complete description of unregistered horses must accompany nomination in futurity or derby. All horses are subject to veterinary inspection and management reserves the right to reject any questionable entry. Substitutions allowed at the discretion of CSR.

4. \$5000 TRIPLE CROWN FUTURITY BONUS: Horses must be Triple Crown 100 enrolled, no additional fees. Must fill out entry form to receive bonus money (form attached). FMI visit triplecrown100.com

5. \$10,000 CSR SALE GRADUATE FUTURITY BONUS: Must have been consigned to CSR Performance Horse Sale, no additional fees, pays 4 places on average time, \$4000, \$3000, \$2000, \$1000.

6. \$5000 WPRA-PESI FUTURITY BONUS: Horses must be PESI enrolled and rider must be a WPRA member, no additional fees.

7. \$2500 WPRA-PESI DERBY BONUS: Horses must be PESI enrolled and rider must be a WPRA member, no additional fees.

8. THERE WILL BE TWO GOES. The first go will be Friday, March 19 at 1pm. The second go will be Saturday, March 20, at 8am. The derby will start one hour after the end of the futurity. There is a 5-second penalty for each knocked over barrel. Horses will run in reverse order the second go. Total time of the two goes will determine the average winners and championship standings. Futurity and Derby entries can roll their times to the Open 5D on Saturday.

9. FUTURITY NOMINATION FEES: A fee of \$200 is required by January 15 for nomination, \$150 to sustain nomination by February 10 and \$150 by March 5 to complete entry. There is a \$25 late fee for each missed payment. Late nominations will be accepted with submission of missed payments until March 19. Eighty percent of the entry fee will be added to the purse. The division of the purse will be 33.3% to each go and to the average.

10. DISTRIBUTION OF 2D PAYOUT, 70% OF TOTAL PURSE TO 1D, 30% TO 2D:

- 1-20 horses: 3 monies (50-30-20)
- 21-30 horses: 4 monies (40-30-20-10)
- 31-50 horses: 5 monies (30-25-20-15-10)
- 51-70 horses: 6 monies (30-24-18-12-9-7)
- 71-90 horses: 7 monies (25-21-17-14-10-7-5)
- 91-110 horses: 8 monies (23-19-17-14-11-7-5-4)
- 111 and over horses: 9 monies (21-18-16-14-11-7.5-5-4-3.5)

11. 1D DERBY NOMINATION FEES: A fee of \$75 is required by January 15 for nomination, \$75 to sustain nomination by February 10 and \$100 by March 5 to complete entry. There is a \$25 late fee for each missed payment. Late nominations will be accepted with submission of missed payments and late fees until March 19. Eighty percent of the entry fee will be added to the purse. The division of the purse will be 25% to each go and 50% to the average.

12. DISTRIBUTION OF 1D DERBY PAYOUT:

- 1-10 horses: 3 monies (50-30-20)
- 11-20 horses: 4 monies (40-30-20-10)
- 21-30 horses: 5 monies (33-27-20-13-7)
- 31-40 horses: 6 monies (29-24-19-14-9-5)
- 41-50 horses: 8 monies (24-20-17-13-10-7-5-4)
- 51 & over horses: 10 monies (21-18-15-13-10-8-6-4-3-2)

13. FEES must be paid in US funds. No refunds in any event. Payment must accompany nomination. *Nominations are considered incomplete and late if not accompanied by copy of papers or vet's affidavit of age.*

14. DRESS CODE: Cowboy hat or helmet, long-sleeved shirt, western pants and boots are required attire for futurity, derby and open entries.

15. ARENA RULES: Must run in and out of the arena. No circling once horse enters the alleyway.

16. RIDER MUST BE NAMED before start of futurity or derby. No rider changes after start of futurity or derby.

Purpose of Form
